#### Case No. CCLU 2024-0002

APPLICANT: Ironman Hitch LLC - Eldon & Sarai Rizzi

<u>BACKGROUND</u>: An application for a Special Use Permit was filed with the Land Use Office on February 5, 2024. The property is owned by Eldon & Sarai Rizzi. It is zoned Rural and is legally described as: 21 ± Acres located in a fraction of the West Half of the Southwest Quarter of Section 10, Township 34 North, Range 9 East, NMPM, Conejos County Colorado. The common description of the property is 14995 County Road R – west side of US Hwy 285 north of Romeo. Parcel/Schedule #586710300278.

REQUEST: The applicants are requesting a Special Use Permit for the truck bed hitch & welding business, farm & ranch supplies retail sales, trailer sales and proposed storage facility. The first Special Use Permit was approved on November 15, 2007, for a Home Occupation for welding and hitch business.

ADJACENT ZONING: North, South, East and West are all Rural.

<u>APPLICABLE ZONING ORDINANACE</u>: - Article 4 Zoning, Division 4.2 Zone District Regulations AND Article 5 Permits, Division 5.4 Special Use Review.

PUBLIC NOTICE REQUIREMENTS: Notice requirements were met by sending notice to the surrounding landowners within 500'on 02/20/2024; notices to referral agencies on 02/20/2024; notice was published in VALLEY COURIER on 02/20/2024 & 03/05/2024; and Onsite posting was posted by Inspector, Pres Romero on 02/20/2024.

PLANNING COMMISSION - The public hearing is scheduled for Wednesday, March 20, 2024, at 6:15 PM.

BOARD OF CONEJOS COUNTY COMMISSIONERS - The application will be presented to the Board of County Commissioners on Thursday, March 21, 2024, at 10:00 AM.

- Access to the storage units will be located off County Road R and not from Highway 285.
- Storage will be covered and can accommodate RV's, Camper Trailers, UTV/ATV's Snowbiles.
- Ironman Hitch will have specific requirements to ensure that they do not have renters bring old and dilapidated vehicles.
- Renters will sign an agreement to abide by Ironman Hitch rules and regulations.

CPW has received your request for comments on the Ironman Enterprises LLC Storage Unit Project (Permit #CCLU-2024-0002). After consideration we have determined the following:

The property in question is in an area already utilized for commercial use, and is directly adjacent to State Highway 285. It is property that previously has been used for irrigated crop production, but such use has since been abandoned. No significant wildlife activity has been documented on the property, No significant wildlife impacts are anticipated.

Hello Eldon and Sarai Rizzi,

Thank you for your inquiry with CSFS on whether you need a wildfire mitigation plan for your Conejos County Special Use Permit. I visually inspected the property via aerial imagery, and I am also familiar with the general area. Your area is surrounded by agricultural land and shrubs that are well spaced and shouldn't need much mitigation work.

You should consider a few safety precautions for your business.

- 1. Ensure any new landscaping confirms with our publication The Home Ignition Zone, A guide to preparing your home for wildfire and creating defensible space.
- 2. Control vegetation surrounding the proposed storage structures. Keeping a no vegetation zone within 5' of the structures.

- One of the Ambulance is in the shop and requires significant repair, because of the oil pan and vacuum pump leaking.
- Ernest states that they cannot do any out of Valley transfers because they are down to one Ambulance, while the other one is in the shop.
