- Victim Advocate Funding discussion.
- Celebration in Manassa found that there was no cell service in the Town, this caused more of an alarm then any major issue, but the Town will raise issue with Cell Service providers.
- Filming a movie in Capulin, deputies are getting paid by film production company for security.
- Another deputy lost to another County due to lower wages offered by other Counties.
- No Call Sheet but the calls for July have increased.
- Sheriff's department is working in a grant for Starlink and enclosed Side by Side.
- Sheriff discusses possible Fire Ban if dry conditions continue.

APPLICANT: Lance & Kayla Hostetter

<u>BACKGROUND</u>: An application for a Special Use Permit was filed with the Land Use Office on June 22, 2023. The property is zoned Rural and is legally described as: TR 1 of the Hostetter Division of Land in the NW1/4 of Section 13, Township 35N, Range 9E, Conejos County, Colorado. Physical address is 19980 County Road 17 in La Jara.

<u>REQUEST:</u> The applicant is requesting a Special Use Permit for Short Term Over Night Lodging.

ADJACENT ZONING: North, South, East and West are a mix of Rural & Agricultural lands.

<u>APPLICABLE ZONING ORDINANACE</u>: - Article 4 Zoning, Division 4.2 Zone District Regulations AND Article 5 Permits, Division 5.4 Special Use Review.
