#### REDISTRICTING COMMISSIONER DISTRICTS



After every census the county commissioners of each county in the state of Colorado are required to review the populations within each commissioner district. If the review finds that there is a 5% or greater deviation between the most populous and the least populous commissioner district, then the commissioners must convene a Commission and begin the work to reapportion the populations within each district to be as equal as possible.

The commissioners have convened a Commission that is presenting two options/maps (options 1 and 2) for the Board of County Commissioners to eventually adopt one of the two maps. The two maps are posted on the new Conejos County website:

conejoscounty.colorado.gov Both maps are also posted for inspection in the south hallway of the Courthouse, in the hallway leading to the County Clerk's Office.

The Commission is requesting county residents study both maps carefully. After reviewing both maps, one can comment using the link provided and it would help the commissioners if your comment would contain the map you prefer and the reason/s. Written comments, public hearing testimony and commission planning meetings will be the driving force on which of the maps the commissioners adopt. The commissioners have until September 30, 2023 to complete the redistricting of the commissioner districts.

Options 1 and 2 Maps: The significant proposed change to commissioner districts in both maps is the Town of Romeo is divided by Colorado State Highway142. The maps indicate the residents of Romeo that live on the south side of Colorado State Highway142 would now be in Commissioner District 1 and the residents of Romeo that live on the north side of Colorado State Highway142 would remain in Commissioner District 2.


The Board of County Commissioners have scheduled a public hearing on January 24, 2023 at 6:00 p.m. at the Conejos County Courthouse in the commissioner's board meeting room. Citizens will have an opportunity to appear in person and comment on the map they believe best suits the interest of the county. All website comments will be read at the public hearing and must be considered equally as those communicated in person.

The last time Commissioner Districts were reapportioned was in 2010.

The Board of County Commissioners sincerely "Thanks" businesses for making the changes to your point of sale, collecting and submitting retails sales taxes! Tax revenues were sent back to the county by the Colorado Dept. of Revenue beginning in March, 2022; except for the use tax which is collected locally by the Land Use Office. At year end or early 2023,, the county will receive the 2022 January and February retail sales tax revenue. Here's an update to begin the new year of 2023. Our office will be mailing out tax notices on or about January 13<sup>th</sup>. If you do not receive yours by the end of January, you are welcome to call us and we will verify the mailing address we have for you.

First half tax payments are due by February 28, 2023 and second half tax payments are due by June 15, 2023. Full payments are due by April 30, 2023.

Your cancelled check will be your receipt unless you request a receipt and send us a self-addressed stamped envelope with your payment. Please note you can either mail your payment to: PO Box 97, Conejos, CO 81129, or pay online at: **conejoscounty.colorado.gov** (Please note this is our new County Website Address!) or call our office to make a payment over the phone. Please be aware there is a small convenience fee for debit cards, credit cards and e-checks.

The Sheriff's Office has been busy the last year responding to all types of calls, to the tune of 6556 calls for service. Everything from fires, medical assists and break-ins to threats toward our public schools. Our Deputies have responded to every call promptly and professionally. Detailed investigation and hard work have resulted in several arrests, including the apprehension of individuals stealing Catalytic Converters in the area. Investigations are continuing and more arrests are expected.



Greetings to all the Residents of Conejos County and Interested parties, the Conejos County Office of Emergency Management wishes everyone a Very Merry Christmas and a Happy New Year!

It is amazing to see the Responders of the SLV work together for the benefit of all.



The Colorado Aspen Fire on Dec 2, 5:44 (first Picture) to later that afternoon (\$400,000 loss.) There were multiple fire departments that responded. Devin Haynie and Cody Sullivan (Incident Commander) from DFPC - San Luis Valley and their crews assisted the Alamosa, Rio Grande and Conejos County Fire Departments. The Conejos County Sheriff's Department and Emergency Manager also were present and assisted as needed. Rocky Southway sent a large front end loader to assist.

We have had 2 major fires in Conejos County this year and the cooperation and response from all agencies is what makes the Valley a great place to live! The Menkhaven Fire this past June lasted 8 days and cost \$1,400,000. There were many fire departments that responded to this fire with the Romeo Fire Department staying the entire 8 days, under the control and direction of the Colorado Division of Fire Prevention and Control (DFPC) Devin Haynie, Incident Commander.

The San Luis Valley Region and its six participating counties (Alamosa, Conejos, Costilla, Mineral, Rio Grande, and Saguache) are in the final stages of a planning effort to assess risks from natural, human-health, and human-caused hazards and to identify ways to reduce those risks. A planning process that began in February 2022 has resulted in a draft update to each county's existing Hazard Mitigation Plan (HMP) in one cohesive, regional plan. A HMP is required under the Federal Disaster Mitigation Act of 2000 to be eligible to receive certain federal disaster assistance and grants for hazard mitigation projects. A virtual public workshop will be held to introduce the draft plan, its hazards and highlights of the mitigation strategy and will include a presentation followed by a question-and-answer period. The plan will also be made available for public review and comment in January. Following the public workshop and comment period the Plan will be submitted for final approvals and ultimately adoption by all involved jurisdictions.

#### Road and Bridget Department Fourth Quarter Report:

Our road and bridge department has spent the last quarter finishing up maintenance on snow plows and other snow removal equipment including a lawn mower with a snow blade attached to it. We topped off our red rock and salt supply to make sure we have enough to get us through the icy months. We were able to send six crew members to a Winter Snow and Ice training in Longmont this late fall and our crew members were able to see some of the latest snow removal equipment and also learn new and better ways to remove snow and better ways to deal with icy roads.

Winter tends to slow us down in the road and bridge department but we have had some great warm weather and we have taken advantage of these warm days. We replaced two wood wall and deck bridges with concrete and steel bridges that will last for many years and not require the constant maintenance and expense that these old style wood bridges required. The bridges that were replaced are located at County Road M and County Road 15 and the second is located at County Road S and County rRoad 19.

As you all know late fall and winter bring cold and winds, and on a few days our crew was out removing blown over trees and debris from our roads throughout the county.

Other than grading roads and trying to keep up with our regular road, bridge and culvert maintenance we have been and we will be crushing class six road base material at our Romeo gravel pit. We will continue to crush through the winter months and once the seasons allow we will place the processed material until it is exhausted on our higher traveled roads. This is a new process and will take a few years to get this accomplished.

# **Access Permits**



An access is any point of entry/exit to a property. If your entry/exit point is adjacent to a county road, a permit is required per Conejos County Land Use Code Article 14. It should be safe and in conformance with applicable standards. An application can be found by contacting the Land Use Office or the Road & Bridge Department.

Driveway easements (also called access points) should be no less than 30 feet in width. The Road & Bridge Department will perform a site inspection

to determine safety, placement and/or the need for a culvert.

Access points from state highways, forest service roads and BLM roads will need to apply with the appropriate agencies.

# **DID YOU KNOW?**

The use of recreational vehicles for storage, as an accessory structure, or as a dwelling for any purpose other than temporary dwelling for travel, recreation or vacation use is prohibited. The use of a recreational vehicle or a tent is prohibited within a residential district. (i.e., Subdivisions)
