<u>BACKGROUND</u>: An application was filed with the Land Use office on September 24, 2021, for a Division of Land (DOL.) The owners are Jose Amarante Lucero & Diana K. Scott. The property is 25.716 acres being a division of Lot 1 of the JAL Lucero Division of Land located in a portion of the SE ½ SE ½ of Section 20, Township 33 North, Range 9 East, New Mexico Principal Meridian, Conejos County Colorado.

The proposed survey reflects a division of 25.716 act to create the following:

Lot 1-A containing 12.858 acres <u>+</u> Rural - agricultural land Lot 1-B containing 12.858 acres <u>+</u> Rural - residential area County Road G was previously dedicated.

REQUEST: Boundary Line Adjustment

APPLICANT: EXPO, LLC by Jeremy McComas-General Manager

ZONING: Rural

SURVEY BY: Summit Engineering Company

<u>BACKGROUND</u>: An application was filed with the Land Use Office on November 12, 2021, for a Boundary Line Adjustment. The real property is legally described as:

The property is zoned Rural and is 7.80 Acres being Tracts 3B Helms Potato DOL/TR 3 Dix-Helms DOL AND Tract 2 & 3 Helms Potato Minor Subdivision of Tract 3A Helms Potato DOL all located in the Southeast Quarter of Section 13, Township 36 North, Range 8 East of the New Mexico Principal Meridian, Conejos County, Colorado.

<u>Applicable Land Use Codes</u>: Article 10 - Subdivision, Division 10.7 Subdivision Exemptions, Section 10.7 (2.) Boundary Line Adjustment & Lot Line Revision

The proposed Boundary Line Adjustment of the property will create the following:

Tract 2R Containing 3.412 Acre ± Tract 3BR Containing 4.379 Acre ±

The owners adjusted the boundaries of the tracts as they plan to place an addition on the warehouse and would violate setbacks. They chose to eliminate all of Tract 3 of the Helms Potato Company Minor Subdivision and consolidate it into Tract 2R. They moved the northwest boundary of Tract 3B that ran southwest to the north of the shed running northwest. This should allow them enough space to meet setbacks for their proposed building.
