# Larry Brown - Extension - Conejos County Position Discussion

- 90 4-H members in Conejos County
- Can the county use TANIF or ARPA funds to pay for 4-H Coordinator?
- Nick Barela joins discussion regarding funding for the 4H staff member.
- Nick Barela and Larry Brown will discuss options to fund staff member.
- 1 out of 3 schools in Conejos are Title One
  - Only Title One schools qualify for ARPA Funds.
  - o BOCC needs to find a way to fund 30 hour a week coordinator position.
    - Can a booth be set up outside of schools to get kids registered through the TANF program?
    - Can be a good way to get a count of youth that would be interested in the program
    - Trying to figure out how to make a position a permanent as head of program position and not just a fund-based position
    - Possibly using ARPA funds as well as TANF funds
    - Larry asked if he could come back in April or May to give an update

#### Tressesa Martinez and Nick Barela-Gobin's Camera systems

- ARPA funding could be used to install and keep cameras
- Verkada will be the main system for usage
- The system is very advanced
- Cameras has facial recognition.
- Vehicle License plate recognition.
- The price can be spread out through out a 10yr period
- A total of 85 cameras will be needed for offices between DSS, the courthouse, the jail and nursing.
- Camera range is very far with high clarity.
- System can break out a video and create a link that can be sent to Dept. Head or Elected Official for review.
- All recorded files are time stamped.

**BACKGROUND:** An application was filed with the Land Use Office on November 29, 2021, for a Boundary Line Adjustment. The real property is legally described as:

38.217 Acres in Tract 2 of the Jack Gilleland DOL located in the NW  $^{1}$ 4 SE  $^{1}$ 4 of S23-T34N-R9E. NMPM. Conejos County Colorado. (Owners Gilleland Heritage LLC.)

2.82 Acres in Tract 1 of the Jack Gilleland DOL located in the NW ¼ SE ¼ of \$23-T34N-9E. NMPM, Conejos County, Colorado. (Owners are Mark & Nancy Gilleland.)

Both properties are zoned Rural.

The proposed Boundary Line Adjustment of the property will create the following:

Tract 1 containing 5.251 ± acres – Lot for Mark & Nancy Gilleland Tract 2 containing 35.790 + acres – Lot for Gilleland Heritage LLC

The landowners are adjusting the property boundaries to enlarge the southern boundary of Tract I. The land being enlarged is northeast of the existing ag land under a pivot sprinkler. The home and outbuildings are on this property.

BACKGROUND: An application was filed with the Land Use office on 12/21/21, for a Division of Land (DOL.) The owners are Robert Horton and Gail Horton. The property is legally described as 120 Acres situated in the SW ¼ NW ¼ and the N ½ SW ¼ 31-36-9 NMPM, Conejos County CO. The property is zoned Rural.

The Division of 121.648 acres will create the following:

Tract 1 containing 110.826 acres <u>+</u> ag land Tract 2 containing 9.000 acres <u>+</u> residential/rural land Right-of-way - State Hwy 371 containing 1.822 <u>+</u>

Applicable Codes Used: Article 10 - Division of Land

<u>Purpose of Division</u>: The applicants requested a division of land to separate the agricultural use land from the residential use land.

I have one issue. There is an old storage shed on the property that is currently 19' from the new property line. That creates a violation to our setback regulations. Mr. Horton has agreed to remove the shed within 1 year. I request that it be a condition of approval.

- Denise asks that an IGA be signed by the BOCC Chair for SLV Environmental Health.
  - o SLV Public Health Coalition
  - Coalition of all 6 SLV counties that pay for Epidemiologists and Environmental Health Inspector.
- Decrease of food commodities given out
- When other food drives are given out the decrease is greater
- \$36,000 was sent to public health covid funding
- Public health still has available positions open
- Free Covid testing is coming to an end soon
- Public health will give extra testing kits to people who test and have families
- There is only five case managers throughout Conejos and Costilla counties for nursing
- There is a decrease in PCP's
- Hours are limited to minimum as clients have said they are concerned about being exposed to covid

#### Comm. Garcia called meeting to board of health at 11:12

- Sexual Transmitted Dieses increase 2022-2021
- o Denise received an alert from disease control wanting to partner with them as the numbers were drastically high
- o Binx boxes will be given; this is a self-testing kit that is totally anonymous
- O Denise mentioned talking with local businesses to see about making contraceptives available and free for people to protect themselves.
- o Numbers of people tested went outside of the valley for testing
- o Public health will start taking in needles and shape exchange from the public
- o Public health is reaching out to local schools to have presentations on vaping for kids.
